Evaluating the expected expanding of EU towards East and including of new Central and East-European languages into the list of official EU languages and with respect to the advantageous location of the Czech Republic where the East and West meet, in 1998 was established the translation agency A–Z Lingua.

Location

It is a private company registered in Prague, Czech Republic with headquarters situated in the business centre of city – the Wenceslas square. The modern office centre ensures next to all basic business facilities also a good atmosphere for both employees and clients of the company.

One of our main principles is that the target language is to be a mother language of the translator/proof-reader. That is why the initial team of translators had been chosen among:

- foreign students and lectors of the language departments of Charles University in Prague
- communication department of the Czech President Office
- court interpreters
- bilingual freelancers living in Prague

This allowed is to provide high-quality translations already from the very beginning of the company existence.

The number and volume of orders, language combinations and special demands of the clients constantly grew, so the need of further and more diversified sources appeared. Next to the keeping up the core team, we have widen our source base up to 500 freelance translators. Recruiting of new courses is a constant process which includes:

- evaluation of background
- completing of test translation
- evaluation of test translation quality by company's proof-reader
- basic instruction on company's demands and practices
- regular checking or proof-reading of completed jobs, including immediate feedback

Translations

Translation of hardcopy or e-format text with the use of Windows and all main text and data processing programs and TM tools.

Proof-reading

Basic proof-reading of all completed jobs by the in-house controller and poof-reading by a native speaker in case of translation provided by non-native speaking source - both included in the translation service.

Paid proof-reading on order provided by third (independent) proof-reader.

Court or notary verification of any personal or company document for the purposes of submitting to any authority (courts, police departments, embassies, consulates, chambers, tax authorities, registries, customs etc.) in Czech Republic and all European countries. Preparing documents for Prague Companies Register, Czech Criminal Register, Registries of Births, Marriages and Deaths, Czech Foreign Police on a daily base.

Multilanguage projects management

Mainly for translations into Central and East-European languages but with experience with almost all West-European ones; active use of CAT tools; over 3.000.000 words translated – see list of clients on www.azlingua.cz.

Language Training

It was provided in our own classroom in the same modern centre in the downtown Prague. Trying to escape from the traditional image of classroom and to make the atmosphere spontaneous, the students sat at a round table, talking with the teacher at a cop of coffee, tee or soft drink.

The groups consisted of 4 to 6 student as the larger numbers decrease the time individual student talk or are active.

The teachers were chosen on the base of not only excellent language skills, but in-country stays, communicative and improvising skills and good style.

We also organised in-company fitting to the client's remands on field, level and time schedule.

The courses were very successful; most of the students attend next levels, many new students came by word of mouth.

However the translation service was our main activity, on which we decided to put the stress and to enlarge its scope. For this reason, in year 2000 stopped organising new language courses and gradually cease the language training activity (last training completed at the end of 2001).

Spreading and Development

Taking into consideration of the new market realities (some new legal rules in the Czech Republic, globalisation, spread of Internet and e-services etc.) the company owner decided to put the emphasis of company's future development on:

 Transfer from personal into maximal possible electronic way of communication, marketing and service offering

- Spreading from mainly Czech client base to all-European one
- Focusing on larger clients (direct clients or translation companies), including undertaking of multilanguage projects
- Spreading from mainly Prague source base to all-Czech and all-European one by also contracting with foreign vendor companies

In 2000 A–Z Lingua registered a branch office in Hungary. It has been providing a support activity to the main office for the multilanguage projects as well as acting on the Hungarian translation market.

For the purposes of spreading of source base, quality of delivered services, keeping of advantageous price rates, meeting of demands of multinational clients and multilanguage projects, A–Z Lingua collaborates actively with vendor companies in Slovakia, Hungary, Romania, Bulgaria and Russia.

Currently more than 90% of company's clients order in electronic way and over 80% of communication with the sources flows via Internet.
